Acting Director of the Mineral and Energy Economy Research Institute, Polish Academy of Sciences in Cracow, announces a competition for the position of research assistant in the scope of engineering and mining geophysics in the DIVISION OF GEODYNAMICS AND ENVIRONMENTAL ENGINEERING.

Candidates should meet the conditions set out in Article 89, paragraph 4. Act on the Polish Academy of Sciences of April 30, 2010, with subsequent changes.

Requirements:

- possession of the master's degree in the field of engineering and technology sciences or in the field of exact and natural sciences,
- possession of a certificate confirming knowledge of English or another congress language (German, French, Spanish, Russian, Italian) at a level of at least B2,
- demonstrating an aptitude for scientific work (achievements and involvement in works related to the issues required by the competition).

An additional advantage will be:

- experience in the implementation of projects and research services in the scope of engineering and mining geophysics,
- knowledge of computer programs for processing geophysical data and general applications, including graphics,
- presentations at specialist conferences,
- authorship or co-authorship of articles in specialist journals.

When entering the competition, you must provide:

1. Application for employment addressed to the acting Director of the Institute with a signed information clause (Annex 1).
2. CV.
3. Copy of the master's degree diploma.
4. Certificate confirming knowledge of a foreign language mentioned in the requirements.
5. List of publications and implemented projects or research services.
6. A statement that the Institute is the basic place of work (if the competition is won).
7. Declaration of acceptance of the terms of the competition.

1. Full time work.
2. Employment period - for an indefinite period from **15th December 2024**.

4. The deadline for submitting documents is **22nd November 2024**.
5. The competition will be settled on **25th November 2024**.

Information clause

In accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2018, item 1000) and in accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (GDPR), we would like to inform you that:

2. The administrator has appointed a Personal Data Protection Inspector who can be contacted in all matters relating to the processing of personal data by the Institute and the exercise of rights related to data processing by e-mail at the following address: inspektorODO@min-pan.krakow.pl.
3. Your personal data will be processed only for the purpose of conducting a competition for the position of an assistant at the DIVISION OF GEODYNAMICS AND ENVIRONMENTAL ENGINEERING - the legal basis for the processing of your personal data is art. 6 sec. 1 letter c of the GDPR.
4. You have the right to access your personal data and the right to rectify it, the right to request deletion, processing restrictions, the right to transfer data, the right to object to the processing of data, the right to withdraw consent (if granted) at any time without giving any reason, without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal.
5. Providing your personal data is voluntary, but failure to do so makes it impossible for you to consider your application.
6. From the moment of obtaining your personal data will be processed for the period necessary to achieve the purpose indicated in point. 3, and thereafter for a specified period in the provisions of the Act of July 14, 1983 on the national archival resource and archives (Journal of Laws of 2019, item 553).
7. Your personal data will not be shared with other entities (administrators), except for entities authorized under the law. The administrator will not transfer your data outside the European Economic Area.
8. The data administrator does not profile you.
9. You have the right to file a complaint with the supervisory body - the President of the Personal Data Protection Office (Warsaw, ul. Stawki 2), if you feel that the processing of your personal data violates the provisions of the GDPR.
